  - C. Qayb U baahan xaqiijin Sharci ah sida lagu dhacay ama ay ku luntay, si markaa loo ogaado halka ay maro, iyo Khaanadda ay gasho.
  - D. Qayb la isku haysto Wakiillada iyo Maamulka oo u baahan in lugu kala garbaxo Sharecada Islaamka.
  - E. Qayb hanti maguurto ah oo hadda taalla una baahan in la qiimeeyo dabadeed la iibiyo loona qaybiyo dadkii ay wax ka maqnaayeen.




- A. In ay u istaagaan raadinta iyo soo ururinta hantidii Shirkadda ka maqanayd.

  - E. In ay la socodsiiyaan Guddiga Culumada hadba meesha ay wax u marayaan, si talo bixin looga siiyo.




